The things that have been explained above are reinforced by Lickona's statement in Mursidin (2011, 14) that there are 10 signs of the destruction of a nation, including increased violence teenagers or students; use of bad language and words: the increasingly guidelines for good and bad morals; lower respect for parents and teachers; the low sense of individual and civic responsibility in the country; and culture of dishonest behavior. At least, this moral deviation can be minimized with a good educational process. In the scope of school students are not only taught about the subject matter but also about moral knowledge. knowledge provides an understanding of good and bad things, and how to act amid community interactions and applicable norms. Therefore, students' intelligence needs to be developed so that students can do something good and right according to their moral beliefs. John Creswell (2015, p. 408) suggests that "Maximal variation sampling is a purposeful sampling strategy in which researchers take samples of cases or individuals who differ in certain characteristics or characteristics (for

example, different age groups)".
